CourtAlert[®] CM/ECF iPad app – Case to Go:

iPad has a user friendly method for reading PDF files – fingers control zoom and varying speeds.

CourtAlert CM/ECF makes it easy to record dockets and store the applicable PDF files at no additional cost.

The CourtAlert iPad application allows CourtAlert CM/ECF users to download selected dockets, diaries and PDF files onto an iPad. It will be available soon, for free, at the virtual “Apple Store”.

The Case to Go app allows a user to review the case information in an unprecedented user friendly style, including the viewing of the PDF files on the iPad.

A virtual “litigation folder” can be created for partners or attorneys to take to trials and meetings. The color-code labeling of certain dockets within or over multiple cases can be used to select dockets for download onto the iPad.

The firm’s Information Technology Department is notified so that the download is controlled and secure.
