

# CourtAlert® - Points to Remember

## Reminder of CourtAlert® Profile Administration

- A firm may have any number of user profiles. Each user profile can be an “Inquiry Only”, “Case Watch” or “Administrator”
- One central program available to the administrator(s) to maintain user profiles and maintain which users watches what cases

There is no additional charge for concurrent watches of the same case. For example: If two users watch the same case, only one watch charge applies.

<b>USDC Southern District of NY</b>		Opinions , Orders , etc. Alerts are sent before the orders are available through ECF
<b>Every US District Court</b>	CourtAlert for Pacer	At the frequency specified, brings all Pacer dockets (and optionally PDF files)
<b>Every US Bankruptcy Court</b>	CourtAlert for Pacer	At the frequency specified, brings all Pacer dockets (and optionally PDF files)
<b>US Circuit Courts</b>	CourtAlert for Pacer - All Circuit Courts other than the Federal Circuit Court	At the frequency specified, brings all Pacer dockets (and optionally PDF files)
<b>Business Development Alerts</b>	SDNY in Manhattan	Newly filed complaints against a specified name/NOS
<b>Business Development Alerts</b>	NYS Supreme New York County NYS Supreme New York County Commercial Division	Newly filed complaints against a specified name, complaint copy available for Commercial Division
<b>National Business Development Alert</b>	Every Pacer Court: District, Bankruptcy and Circuit	Copy of complaint available immediately
