National Business Development Alert Service

CourtAlert currently offers a Business Development Alerts in the Southern District of New York and NYS Supreme/NY County – the quickest way to see newly filed complaints with specified names listed as a defendant.

CourtAlert currently offers a national CourtAlert for Pacer service. For court, index number and at the frequency specified, CourtAlert provides all new Pacer dockets with the option to download the PDF files.

CourtAlert announces a National Business Development Alert Service for new filings with watched names. This service covers all federal courts in the US.

- CourtAlert will electronically check every Pacer system in the country daily: District, Bankruptcy and Circuit Courts
- Clients list names – use of “wild card” is supported; for example: “Court*Alert” will include “CourtAlert” as well as “Court Alert”
- Alert is produced if the watched name is listed as a defendant or a plaintiff, not just defendant.
 - Client can select plaintiff or defendant and can narrow the search by Nature of Suit
- The “hit” alert contains relevant case information (all parties, attorneys and nature of suit)
- While reviewing the “hit” alert, if the user is interested, a copy of the complaint is immediately available
- The search can be limited to Nature of Suit for each watched name – so a specific partner can receive alerts for a case category they specialize in
- If the user is interested, by clicking a link the case is put on CourtAlert for Pacer watch. The user is then updated with new Pacer dockets
- Alerts can be directly emailed to partners. Up to 4000 characters of email addresses can be added for each watched name
- Low costs:
 - \$3/ a month, calculated daily, for each name watched (“wild card” support at no additional fee)
 - \$13 / “hit” – an alert specifying a new complaint has been filed against a watched name
 - \$33 / copy of the complaint, available immediately
- If the user puts the case on CourtAlert for Pacer to continue to watch the case, standard CourtAlert for Pacer watch rates apply. CourtAlert for Pacer is superior in quality and features and rates are a small portion of the competitor’s rates
- The alert can be sent via SMS to the users and attorneys if SMS information is provided for the watched name
- SNDY and NYS/NY County Business Development alerts will continue to be available at least 24 hours before the new National Business Alerts since we manually collect the information at the courts’ cashier and not electronically from Pacer
